MILL DOG REHABILITATION & CARE - RESCUED DOGS ARE BROUGHT TO NMDR'S KENNEL FACILITY WHERE THEY RECEIVE A COLLAR AND IDENTIFICATION TAG, A CURSORY MEDICAL EXAMINATION, REQUIRED VACCINATIONS, PARASITE CONTROL MEDICATIONS, GROOMING, AND, FOR THE FIRST TIME IN THEIR LIVES, EACH DOG IS GIVEN A NAME. WITHIN 2-3 WEEKS, EACH DOG IS SPAYED OR NEUTERED, RECEIVES A THOROUGH DENTAL TREATMENT, IS HEARTWORM TESTED, IS MICRO-CHIPPED, AND RECEIVES NECESSARY CORRECTIVE SURGERIES PRIOR TO BEING AVAILABLE FOR ADOPTION. THIS CARE IS PROVIDED BY PAID AND VOLUNTEER VETERINARY STAFF IN OUR TWO ROOM VETERINARY CARE CENTER. IN ADDITION, MORE THAN 500 VOLUNTEERS MAKE UP DAILY KENNEL CLEANING CREWS, REHABILITATION AND SOCIALIZATION TEAMS, MEDICATION DELIVERY TEAMS, FOSTER CARE AND ADOPTION TEAMS, AND GROOMING/BATHING TEAMS IN ORDER TO CARE FOR RESCUED DOGS.

MILL DOG RESCUE- IN 2011 NATIONAL MILL DOG RESCUE CONDUCTED 16 RESCUE MISSIONS, TRAVELLING OVER 35,000 MILES TO RESCUE 1,435 PUPPY MILL SURVIVORS FROM INHUMANE CONDITIONS IN WHICH THEY HAVE LIVED FOR YEARS. THE PHYSICAL AND EMOTIONAL TOLL ON VOLUNTEER RESCUERS IS IMMENSE BUT PALES IN COMPARISON TO THE SATISFACTION OF FREEING THE DOGS AND PREPARING THEM FOR HAPPIER LIVES AS FAMILY PETS. OF THE 1,435 DOGS RESCUED, 876 WERE BROUGHT BACK TO NMDR'S KENNEL FACILITY AND 559 WERE TRANSPORTED TO NMDR RESCUE PARTNERS AROUND THE COUNTRY.

MILL DOG KENNEL FACILITY- NMDR HAS AN 11,000 SQUARE FOOT, NO-KILL KENNEL FACILITY LOCATED JUST EAST OF COLORADO SPRINGS, COLORADO. IN THIS FACILITY, RESCUED DOGS ARE HOUSED IN INDIVIDUAL, SPACIOUS INDOOR/OUTDOOR KENNEL RUNS. IN ADDITION TO VETERINARY, REHABILITATIVE, AND GROOMING CARE RESCUED DOGS RECEIVE DAILY EXERCISE AND SOCIALIZATION IN LARGE OUTDOOR PLAY YARDS. ON A TYPICAL DAY VOLUNTEERS CARE FOR 100-120 DOGS AS THEY AWAIT PLACEMENT IN THEIR FOREVER ADOPTIVE HOMES. IN 2011, NMDR PLACED 693 DOGS IN PERMANENT, ADOPTIVE HOMES AND 439 DOGS IN TEMPORARY FOSTER HOMES. THE KENNEL IS MAINTAINED IN IMMACULATE CONDITION WHICH IS A SOURCE OF GREAT PRIDE FOR OUR DEDICATED VOLUNTEERS.
